 - "College Student Interview and Job Preparation Workshop:" The goal of this workshop is to help prepare college students (undergraduate and graduate) for their job search, interview, and career. The workshop can be completed virtually over multiple sessions. The students would be asked to prepare "mock" application materials (e.g., cover letter and resume) that would be reviewed by volunteers. Feedback would be given directly to the students. In addition, a peer review process can be added so students have a chance to provide feedback to other students. The following workshop presentations are suggested: AWMA Overview and Importance of Professional Development, Job Search Preparation (process, materials), Overview of the Interview Process, General Career Advice
